

South Half of the Northeast Quarter (S1/2 NE1/4) of Section Eleven (11), Township One Hundred Twelve (112) North, Range Thirty Three (33) West, EXCEPTING THEREFROM the following described parcel, to-wit:

That part of the Northeast Quarter (NE1/4) of Section Eleven (11) Township One Hundred Twelve (112) North, Range Thirty Three (33) West, Renville County, Minnesota, described as

Commencing at the East Quarter Corner of said Section 11;

thence North 00 degrees 00 minutes 00 seconds East, an assumed bearing, along east line of said Northeast Quarter of Section 11 a distance of 650.59 feet to the point of beginning;

thence North 90 degrees 00 minutes 00 seconds West 651.00 feet;

thence North 00 degrees 00 minutes 00 seconds East 688.76 feet to the approximate centerline of Ridgely Creek;

thence South 86 degrees 40 minutes 50 seconds East along said approximate centerline 652.09 feet to said east line;

thence South 00 degrees 00 minutes 00 seconds East along said east line 651.00 feet to the point of beginning, containing 10.0 acres, more or less and being subject to easements of record in said county and state;

Tract A: That part of the North Half of the Northeast Quarter (N1/2 NE1/4) of Section 11, Township 112 North, Range 33 West, Renville County, Minnesota, lying southerly of the southerly right-of-way line of Trunk Highway NO. 19 as now located and established;

which lies northerly of a line run parallel with and distant 100 feet southerly of Line 1 described below:

Line 1. Beginning at a point on the north line of said Section 11, distant 725 feet easterly of the North quarter corner therof; thence run easterly on the north line of said Section 11 for 1100 feet and there terminating.


