6. CHARGEBACKS: As a condition to registration and bidding, Buyer agrees that Buyer will not, under any circumstance, initiate a chargeback to Buyer's credit card. If purchased items are not removed by the removal deadline, such purchased items will be deemed abandoned by the Buyer.
